

OVERSEAS STUDENT ENROLMENT INFORMATION

APPLICATION PROCEDURE

1. Send the following to FOUNTAIN College's Admissions office:
 - Your completed enrolment form
 - A copy of the page from your current passport that includes your personal details (name, date of birth, passport number etc.)
 - A copy of your current visa (if you hold one).
 - Any Studies offer to an Australian institution (Language Courses)
 - IELTS 5.5 test results (if available)
2. FOUNTAIN College will send you a "Letter of Offer" quoting fees, payment methods and confirming the dates of your course and your Student Agreement Form. The Student Agreement Form is your enrolment agreement with FOUNTAIN College.
3. Complete and return the Student Agreement Form with your payment.
4. FOUNTAIN College will arrange for the electronic "Confirmation of Enrolment" to be sent to your nearest Australian diplomatic post. A copy can be faxed or emailed to you.

PROVIDING QUALITY AND PROTECTING YOUR RIGHTS

The Australian Government wants overseas students in Australia to have a safe, enjoyable and rewarding place to study. Australia's laws promote quality education and consumer protection for overseas students. These laws are known as the ESOS framework and they include the Education Services for Overseas (ESOS) Act and the National Code. SCHOOL FEES

- The scale of fees for each academic year will be set by the College and notified to parents in the preceding year.
- The College Council reserves the right to alter the scale of tuition fees during the course of the academic year. Any such increase shall come into effect 28 days after written notification of any such increase has been provided to the parents.
- In addition to fees, the cost of books and stationery (dependent on subjects selected) and uniform, is to be met by the parents.
- Overseas students, accounts are rendered twice a year.
- Tuition fees will be charged on a pro-rata basis for those students who commence during any school term.
- **Enrolment Bond** is received per child to maximum of 2 children. (If family has more than 2 children maximum bond payable is \$1000). This is a once of payment and is refundable when child graduates or is withdrawn from the school, providing that there is no outstanding debts.
- **Application Fee** is a non-refundable once of payment which will apply to all new applicants.
- **Tuition Fees** don't cover any costs related to accommodation, transportation, books and stationery.
- **SCSA (Schools Curriculum & Standards Authority)** charges Yr 11 students \$220 and Yr 12 students \$495 to be added to the tuition fees.
